2. Completed nomination papers must be delivered by hand to the Returning Officer, at the address shown below on any day from the date of this notice, on Monday to Thursday 8.45am to 5.15pm and Friday 8.45am to 4.45pm (excluding bank holidays) but no later than 4pm on Thursday 9 April 2015.
3. If any election is contested the poll will take place on Thursday 7 May 2015 from 7am to 10pm.
4. Applications to register to vote must reach the Electoral Registration Officer, at the address shown below by 12 midnight on Monday 20 April 2015.
5. Applications, amendments or cancellations of postal votes must reach the Electoral Registration Officer at the address shown below by 5 pm on Tuesday 21 April 2015.
6. Applications to vote by proxy at this election must reach the Electoral Registration Officer at the address shown below by 5 pm on Tuesday 28 April 2015.
7. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at the address given below by 5 p.m. on Thursday 7 May 2015. The physical incapacity must have occurred after 5pm on Tuesday 28 April 2015. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday 28 April 2015.
